I. RESERVATION, FEE, & SITE DETAILS

- A. Rental Fee:** INTRODUCTORY RATE: \$100 per night per site (valid through December 31, 2026). Total fee must be paid in full in advance of your stay.
- B. Security Deposit:** A refundable security deposit of \$100 is required at the time of booking to cover potential damages or cleanup costs.
- C. Permitted Spaces:** Camping is restricted to designated 40' x 40' plots as shown on the Park map. Common areas are to remain as open spaces.
- D. Check-In / Check-Out:** 7:00 AM Check-In / 11:00 AM Check-Out on the last day. Times must be strictly adhered to.
- E. On-Site Presence:** The primary Applicant signing this agreement must be present on-site for the duration of the permitted use.

PAYMENT NOTE

Date must be confirmed by WCA before making payment. WCA will verify date availability and eligibility before issuing confirmation by phone or email. Do not pay until you receive confirmation from the WCA office. After confirmation, scan QR code to pay online.



II. ACKNOWLEDGEMENT OF SITE CONDITIONS

The Applicant acknowledges, understands, and accepts the following conditions currently present at Pu'uiki:

- A. No Electricity:** The park does not have an electrical supply grid. Campers must bring their own generator or solar power setups if required.
- B. No Potable Water:** There is no drinking water available on-site.

- C. Well Water:** The water supply pumped to the park is unsafe for consumption and cooking.
- D. Restrooms:** Restroom facilities are limited exclusively to the Kukui Pavilion. Showers are limited to water hoses that drain directly into the ground. Campers are strongly encouraged to use only earth-friendly, biodegradable products.

III. PARK RULES & STEWARDSHIP

- A. Site Stewardship & Trash:** The park operates on a strict "Pack it in, Pack it out" policy. The Applicant is completely responsible for removing all trash from their designated campsite upon check-out.
- B. Quiet Hours:** Strict quiet hours are enforced from 9:00 PM to 7:00 AM. No amplified music, loud electronics, or disruptive noise is permitted after 9:00 PM.
- C. Fire Safety:** No open ground fires are permitted anywhere in the park. Fires must be entirely contained within elevated self-contained pits brought by the camper.
- D. Vehicles & Parking:** Vehicles must park strictly within designated parking areas. Driving or parking vehicles on the grass or outside specified boundaries is prohibited.
- E. Prohibited Items:** Illegal drugs, firearms, and fireworks are strictly prohibited on park grounds. Alcohol is prohibited unless explicitly authorized under event insurance.
- F. Restricted Access:** There is no beach or shoreline access permitted through this rental agreement.

IV. LIABILITY & INDEMNIFICATION

The Waialua Community Association (WCA) is not responsible for any personal injury, illness, property damage, or lost/stolen items incurred during the rental period. The Applicant agrees to release, indemnify, and hold harmless the WCA, its Trustees, officers, and staff from any and all claims or liabilities arising out of Applicant's use of WCA @ Pu'uiki Beach Park.
